2012 SCHOLARSHIP APPLICATION

The Watertown Foundation is a tax-exempt community foundation created by and for the citizens of Watertown. The Foundation enables people with philanthropic interests to support non-profit community organizations and to provide scholarships to Watertown graduating high school seniors assisting them financially in achieving post-secondary education.

Scholarship awards are competitive. Awards are based on information submitted on this application and from the high school scholastic record, test scores, essays, extracurricular and community involvement, and financial information. Awards are the sole decision and responsibility of the Watertown Foundation Scholarship Committee and are based on the committee's judgment of the applicant's submitted application information.

APPLICATION CRITERIA INCLUDE:

- Residency in Watertown for at least three years (regardless of the secondary school attended)
- Academic Merit based on scholastic record
- Contributions to the applicant's school and community as presented on a separate page of activities
- Financial need based on FAFSA information
- Student essay as defined in this application

INSTRUCTIONS

1. The Watertown Foundation must receive Scholarship applications by April 1. Scholarship applications received after April 1 will not be considered. Individual high schools set their own deadlines to comply with this April 1 deadline.
2. Complete all sections of this application. If the applicant feels that certain requested information is not appropriate, reasons for not submitting that information should be submitted separately.
3. All scholarship applications must be submitted through the student's high school guidance office.
4. The Guidance Office will forward the completed application with school transcript and recommendations directly to the Watertown Foundation Scholarship Committee, P.O. Box 117, Watertown, CT 06795.
5. A photocopy of the Student Aid Report (SAR) showing the Expected Family Contribution (EFC) **must be sent directly to the Committee at the above address** (not through the high school guidance office). Students with extraordinary financial circumstances, such as a parent's recent unemployment, should explain these circumstances on a separate statement.
6. Student and parent or guardian must sign application.

Scholarships awarded by the Watertown Foundation are described on the last page of this application. Check the scholarship for which you feel you are qualified (Scholarship Committee may award a scholarship for which you have not applied).

Financial Information

Family financial information is confidential information; therefore, the Watertown Foundation has chosen to require that scholarship applicants provide information on financial need through the analysis of the FAFSA (*Free Application for Federal Student Aid*). This form is used to apply for federal and state student grants, work-study and loans. In addition, most colleges and universities use information from the FAFSA to award non-federal aid. Graduating high school seniors are encouraged to apply online at www.fafsa.ed.gov. FAFSA applicants receive a report called a *Student Aid Report*, or SAR, through the mail or the Internet. The SAR lists the information reported on the FAFSA, and will report the *Expected Family Contribution*, or EFC. Financial need is the difference between your EFC and your college's cost of attendance as determined by your college. Your application for a scholarship *must* include your EFC. (Financial need is not required for application to the Reinhold and Katie DeWitt Scholarship.) A copy of the SAR must be submitted directly to the Scholarship Committee, Watertown Foundation, Inc., P.O. Box 117, Watertown, CT 06795. To determine financial need, the Scholarship Committee uses the Expected Family Contributions (EFC) as determined by the Student Aid Report (SAR) of the FAFSA.

ESSAY

The student essay helps the Scholarship Committee become acquainted with you as an individual in ways different from your academic credentials, involvement, and other objective information. The Committee uses your essay as an evaluation tool. On a separate paper, type an essay of approximately two pages double-spaced (11 pt. font) on one of the topics listed below:

- a) Explain how and why you would change the educational system of this country.
- b) Describe a character in fiction, a historical figure, or a creative work (as in art, music, science, etc.) that has made a significant impact on you.

HIGH SCHOOL INFORMATION *(must be submitted through the high school guidance office)*

Grades: Include a scholastic transcript.

Recommendations: Include two teacher and/or guidance counselor recommendations.

Test information: Applications will not be considered without SAT or ACT scores. All public school applicants must also include Connecticut Academic Performance Test (CAPT) scores.

ORGANIZATIONS AND ACTIVITIES

List on a separate page organizations and activities in which you have participated during the past three years in order of their importance to you. You may include, for example, scholastic organizations or activities, sports, summer study, travel, and church and civic activities. These activities should support the criteria of the scholarship for which you are applying.

RICKY BOZZUTO MEMORIAL SCHOLARSHIP: Awarded to a graduating Watertown High School senior on the basis of scholastic excellence in the areas of mathematics, physical sciences and information technology. The recipient should demonstrate financial need. This scholarship is given in memory of a man devoted to scholarship, country, work, and especially his family.

REINHOLD AND KATIE DeWITT SCHOLARSHIP: Awarded on the basis of academic excellence, demonstrated sensitivity to others needs, and the ability to work cooperatively with those in need. This scholarship is not based on financial need, and is given through the generosity of Mrs. Reinhold DeWitt in recognition of the benefits she and her husband received from their educations that provided them the opportunities for work, friendships, and service to others.

FLETCHER JUDSON MEMORIAL SCHOLARSHIP: Awarded to a graduating Watertown High School senior on the basis of academic excellence and exemplary community service.

GUINEA, SILKS, ORSILLO SCHOLARSHIP: Awarded to two Watertown High School seniors in the top half of their graduating class, have financial need, and have participated in Watertown High School's sports programs as players, cheerleaders, or managers. This scholarship is in memory of three Watertown High School students who died in an automobile accident.

CRYSTAL LUKOWSKI MEMORIAL SCHOLARSHIP: Awarded to a Watertown High School senior intending to pursue a career in health, allied health, or medicine. The recipient must have demonstrated sensitivity to the needs of others and have the ability to work cooperatively with those in need. This scholarship is given in memory of Crystal Lukowski, a special needs student, who graduated from WHS in 1994.

MARTELL MEMORIAL SCHOLARSHIP: Awarded to a student accepted, enrolled or eligible for entry into a technical, business, two-year or professional school (for example, LPN or hairdressing) that meets the approval of the Scholarship Committee. This scholarship is awarded to a student who is in the middle ranking of the graduating class.

MARIGOLD SPENCER MEMORIAL SCHOLARSHIP: Awarded to a Watertown High School senior who has contributed to the community through generous use of time, talents, and leadership. This scholarship is given in memory of a long-time Watertown resident who lived this same spirit of generosity.
